## Training Tools & Equipment

- I understand that **remote training collars (e-collars) are only used with prior owner approval**, and if applicable, I have received education on proper use.

- The Board & Train program provides a **training foundation**, not a lifetime guarantee.

## Post-Program Support

I understand that:
