Terms of Service Agreement

The Everyday Canine, LLC

The Everyday Canine, LLC (“The Everyday Canine”) provides professional dog training, **daycare**, boarding, board-and-train, and related canine services using modern, efficient, and humane methods.

Payment & Fees

All fees are payable in full at the time of booking unless alternative payment arrangements have been made in advance and approved in writing. All fees are **earned upon receipt and are non-refundable for any reason**.

Late payments may be subject to interest at a rate of **2% per month**. Client acknowledges that The Everyday Canine may adjust its fees from time to time and will provide advance notice of any such changes when applicable.

If Client voluntarily removes their pet from services prior to completion for any reason, all fees remain earned and non-refundable.

Vaccination Requirements

Client certifies that all pets utilizing The Everyday Canine’s services — including **daycare, boarding, and training** — are fully up to date on required vaccinations and will remain so throughout the duration of services. Client further certifies that any pet participating in services has received **at least two sets of vaccinations** in the required vaccination sequence.

The Everyday Canine reserves the right to request proof of vaccination at any time and may deny participation if vaccination status is incomplete or expired.

Health & Behavior Disclosure

Client certifies that all known medical conditions, behavioral concerns, bite history, allergies, medications, injuries, prior incidents, and social limitations (including intolerance of dogs, people, or handling) have been fully disclosed in writing prior to services.

Failure to disclose relevant information may result in immediate termination of services **without refund**, and Client assumes full responsibility for any resulting damages, injuries, or expenses.

Right to Refuse or Terminate Service

The Everyday Canine reserves the right to refuse or terminate services — including daycare — at any time, in its sole and absolute discretion, for reasons including but not limited to safety concerns, undisclosed health or behavioral issues, excessive stress, inappropriate play behavior, aggression, or disruptive conduct by the pet or handler.

Abusive, threatening, or inappropriate behavior toward staff will result in immediate termination of services without refund.

Training Methods & Tools Consent

Client acknowledges and consents to the use of training tools deemed appropriate by The Everyday Canine, including but not limited to flat collars, slip leads, long lines, and prong collars, when used humanely and responsibly.

Remote training collars (e-collars) are never utilized without the explicit approval of the pet's owner. Tool selection is based on the dog's temperament, training goals, safety considerations, and owner consent when required.

Sessions & Attendance

- A **no-show** for any scheduled appointment or daycare reservation will be counted as a completed service.
 - Session and daycare participation duration is determined by The Everyday Canine.
 - Time spent discussing training, behavior, handling, or progress is considered part of the service.
 - Pets deemed unsafe, overly stressed, aggressive, or disruptive may be removed from sessions or daycare immediately.

No Guarantee of Results & Behavior Regression

Client acknowledges that dog training, daycare participation, and behavior modification results are **not guaranteed**.

Client understands that **behavior regression or changes** may occur after services conclude or during daycare participation due to environmental changes, overstimulation, or insufficient follow-through at home. The Everyday Canine is not responsible for regression or behavioral changes following services.

Daycare Participation & Risk Disclosure

Client acknowledges that dog daycare involves group play, shared spaces, and exposure to other dogs and handlers. Despite careful screening, supervision, and management, risks exist including but not limited to:

- Minor injuries (scratches, nicks, soreness)
- Illness or exposure to communicable conditions
- Stress-related behaviors or fatigue
- Behavioral changes or social conflicts

Client voluntarily accepts these risks and agrees that The Everyday Canine is not responsible for normal, reasonable incidents associated with canine daycare participation.

Dogs may be separated, redirected, crated, or removed from daycare at any time for safety, stress management, or behavioral concerns.

Boarding & Board-and-Train Risk Disclosure

Client acknowledges that during boarding or board-and-train services, dogs may be exposed to other dogs, new environments, daily handling, and controlled social interactions. These activities carry inherent risks including illness, injury, stress, or behavioral changes.

Client voluntarily accepts these risks and agrees that The Everyday Canine is not responsible for normal, reasonable incidents associated with canine care, handling, or social exposure.

Assumption of Risk & Release of Liability

Client understands that participation in training, daycare, boarding, and related services involves inherent risks. Client voluntarily assumes all such risks.

If Client's pet is injured in a fight or accident; contracts fleas, ticks, worms, illness, or disease; becomes lost or stolen; becomes pregnant; or engages in dangerous, unwanted, or aggressive behavior during or after services, Client accepts full responsibility.

Release & Indemnification

In consideration of services provided, Client releases and forever discharges The Everyday Canine, LLC, its owners, members, managers, employees, agents, contractors, volunteers, insurers, landlords, vendors, and affiliates from **any and all claims** arising from services.

Client agrees to **indemnify and hold harmless** The Everyday Canine from any claims, damages, costs, or expenses (including attorney's fees) arising from the actions or omissions of Client, Client's pet, or any handler.

Veterinary Authorization

Client authorizes The Everyday Canine to seek veterinary care, including emergency treatment, if deemed necessary at The Everyday Canine's reasonable discretion. Reasonable efforts will be made to contact Client prior to obtaining care.

Client agrees to reimburse The Everyday Canine for all veterinary expenses incurred and to provide at least one **emergency contact** authorized to make decisions if Client cannot be reached.

Abandonment

If Client fails to pick up their pet within **7 days** of the agreed-upon end date and cannot be reached, the pet may be considered abandoned. The Everyday Canine may pursue rehoming, surrender to animal control, or other lawful disposition.

Client remains financially responsible for all accrued fees and related costs.

Media Release

Client grants The Everyday Canine permission to use photographs, videos, and other media of Client and/or Client's pet(s) for promotional, educational, or marketing purposes without compensation.

Communicable Disease Acknowledgment

Client understands that participation in daycare, training, and boarding may increase exposure to communicable diseases, including COVID-19 or other viral or bacterial agents. Client voluntarily assumes all associated risks.

Force Majeure

The Everyday Canine shall not be liable for failure or delay due to events beyond reasonable control, including natural disasters, severe weather, power outages, or public health emergencies.

Assignment

Client may not assign or transfer rights or obligations under this Agreement without prior written consent from The Everyday Canine.

Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the **State of Texas**. The prevailing party in any action shall be entitled to reasonable attorney's fees and costs.

Cancellation & Rescheduling Policy

- **48 hours' notice** required for cancellations or rescheduling
- Late cancellations or no-shows result in **forfeiture of payment**
- No refunds for any reason
- Store credit may be issued at owner discretion for timely cancellations
