Client Communication & Operational Boundaries Acknowledgment

I ACKNOWLEDGE AND AGREE that I have reviewed **The Everyday Canine's Client Communication & Boundaries Policy** (provided via hyperlink), including but not limited to:

I voluntarily assume **all risks associated with my dog's participation**, whether known or unknown, foreseeable or unforeseeable.

I expressly agree that **The Everyday Canine, LLC**, its owners, members, managers, employees, contractors, agents, volunteers, insurers, landlords, and affiliates **shall not be held liable for any injury, illness, loss, damage, or incident of any kind occurring while my dog is in their care, custody, or control**, including but not limited to:

- Injuries caused by other dogs
- Self-inflicted injuries
- Illnesses or exposure to disease
- Stress-related behaviors or behavioral regression
- Escape or damage to property
- Accidental injury or death

This release applies **regardless of cause**, except in cases of gross negligence or willful misconduct as defined by applicable law.

I further agree to **indemnify and hold harmless** The Everyday Canine, LLC from any and all claims, demands, damages, losses, liabilities, costs, or expenses (including attorney's fees) arising out of or related to my dog's participation in services or actions while in their care.
